
Dear Third, Fourth, and Fifth Grade Students and Parents,

Congratulations! You are eligible to be in the Chinook Tiger Choir. This group will meet on Monday mornings from 7:45 until 8:35 a.m., beginning September 10. Those students who are members of the Chinook Running Club may also join the Chinook Tiger Choir. They can enroll in Choir now and then begin attending choir rehearsals after the Running Club is finished. We have some exciting plans for the Tiger Choir this year, including performances in the winter and in the spring as well as a Caroling Party for the Chinook neighborhood in December. Although there are no auditions for choir membership, we ask that choir students commit to being regular in attendance at the weekly rehearsals.

This year Academy School District 20 is implementing a new policy of clarifying and simplifying the tuition fees for every school club. The choir tuition fee has been set at \$15 per choir member for the year. Shirts, choir music, and party paper supplies will be purchased with this fee. **The choir shirts will be the same as last year.** Please complete the enrollment form below, along with the attached "Assumption of Risk" form, and enclose the forms and tuition fee in an envelope with your child's name and teacher's name printed on the outside. If your student does not already have a choir shirt, please include the shirt size of your student. The envelopes may be brought to your classroom teacher or to the office. Checks can be made out to "Chinook Trail Elementary."

We could use co-directors, choir secretaries, choir monitors, and parents to help set up, serve refreshments, and clean up at concerts!

**ASSUMPTION OF RISK AGREEMENT TO HOLD HARMLESS AND EMERGENCY RELEASE FORM
REGARDING ELEMENTARY SCHOOL-SPONSORED BEFORE AND AFTER SCHOOL ACTIVITIES**

As the parent/legal guardian of the student named here _____ (child's name),
I authorize my child to participate in a before or after school-sponsored activity at _____.
I understand that school nurses are not on duty after school hours and that in the event of a medical emergency,
school staff will call 911 and parent/guardian. I understand that the health room is not open after school hours.
Therefore, I agree that if an inhaler or epi-pen has been prescribed for my child, I will provide those and I further
acknowledge that my child has been authorized to self-carry by a health care provider. No medication will be
administered by school staff during the before or after-school activity time. If medication is absolutely necessary for
the child during the before or after school activity, the parent/legal guardian agrees to assume responsibility for
administering the medication outside of normal school hours.

Additionally, by signing below, the parent/legal guardian grants permission to an emergency health care provider
to secure proper treatment for the student and the parent/legal guardian agrees to assume all costs for such
treatment.

code of conduct and behavior expectations.
